# SHEEP-WORRYING DOGS.

### WHERE THEY CAN BE SHOT.

An interesting judgment bearing upon the rights of farmers in regard to destroying stray dogs which worry, their stock was given in the Whangarei Magistrate's Court recently by Mr R. W. Tate, S.M. This case was one in which E. B. Laxon (Mr Woods) had claimed £10 as the value of a cattle dog killed by Donald Sinclair (Mr Harrison) without justification, and £5 by way of general damages in respect of the killing of the dog. On August 13 the dog was at large among the defendant's sheep and lambs. When the defendant reached the spot the dog had gone on to a neighbour's property whither he followed it and from there to plaintiff's property, where in the presence of and despite the protests of the plaintiff's wife, he shot it, the whole transaction occupying a very short time.

The plaintiff contended that the shooting of the dog was not justified and the Magistrate thought he was right. The case was, he said, very similar to McCarthy v. McConnell, where a dog was found worrying sheep on a State farm. en a State farm. He was followed off the farm for some distance caught and led back to the farm where, after a lapse of two days, he was shot. The shooting was held to be unjustified and the owner of the dog recovered damages. In the case quoted the law on the subject was fully discussed. The nearest authority to a justification of the present shooting was Wright v. Sharpe, 1902, where an owner found an unregistered dog among his sheep, caught it, led it across a public road intersecting his property, and there shot it. The dog was not at liberty

when the road was crossed and only about five minutes elapsed from its seizure to its destruction. The shooting was justified, but it should be noted that except for crossing the road the dog did not leave the sheepowner's

The Dogs Registration Act 1908 sets out certain circumstances in which the shooting of a dog was justified, regarding those from the point of view of a sheep or cattle farmer. Section 16 permitting any person upon whose land an unregistered dog is found, or his agent, to destroy any such dog and a dog without a collar having a proper registration label is deemed to be an unregistered dog. Section 26 said that a dog running at large among sheep or cattle may be destroyed by the owner of the sheep or cattle or by his agent or his servant, or his employee. Section 25 enacted that any person whatever who saw a dog biting or attacking sheep or cattle may destroy the same. No case was cited and the Magistrate knew of no case justifyingtne following of a dog from the stock owners land to the land of another person and there shooting.

The value of the dog was variously assessed from £10 to nothing, and the Magistrate did not think that a cattle dog that would not work cattle except to bring cows in at his home farm could be of great commercial value. The plaintiff gave 10s for him, presumably as a pup, and the Magistrate thought that £2 10s was a liberal assessment of his value when shot. Plaintiff was entitled to general damages claimed in addition to the value of the dog. Judgment was given for £7 10s and £3 14s costs.
